Year 1 Crime Type Allocation Estimates

Overview

The Year 1 Crime Type Allocation Estimates form is required for all new/opening grants during the Year End reporting period in competitive grant years only.

In the first year of a funding cycle, subgrantees will provide initial estimates of how they plan to allocate VOCA funding to different types of crime. In the remaining years of the funding cycle, allocations from the Crime Type Allocations form for the previous year will be used to calculate the initial estimates for the next year.

Instructions

Enter the percentage (0-100) that your agency *estimates* to spend during the fiscal year of the new grant on each of the VOCA Priority Area categories listed below. Corresponding PMT victimization types are listed as well for reference. The allocation in dollars will be automatically calculated on the web form. These estimated allocations will be updated during the Semi-Annual report, and updated with actual allocations at the next Year End report.

C2	Adult sexual assault	Adult Sexual Assault, Human Trafficking: Sex
D1	DUI/DWI crashes	DUI/DWI Incidents
D2	Assault	Adult Physical Assault (includes Aggravated and Simple Assault)
D3	Adults molested as children	Adults Sexually Abused/Assaulted as Children
D4	Elder abuse	Elder Abuse or Neglect
D5	Robbery	Robbery
