Case Plan			
<p>This section can be used to describe the plan for any case and should be completed when concerning behavior indicates that a plan of support is needed. Keep in mind <b><i>that if a subject is suspended/expelled for concerning behavior, or moves out of the district, this does not eliminate the risk of an attack.</i></b> There will need to be a plan of support to determine if the subject is successfully receiving needed services (deescalating), or if they continue to pose a risk of harmful or unwanted behavior. Appropriate actions in response to the continuation of concerning behavior should be taken to intervene in possible attacks.</p> <p><b><i>*For each action to be taken in the plan, a person should be designated as responsible to complete it and how often.</i></b></p>
